SECTION – 7

SPECIAL CONDITIONS OF CONTRACT

GENERAL:

The Special Conditions of Contract shall be read in conjunction with the General Terms & Conditions of Contract, Schedule of rates, specifications, and any other documents forming part of contract, wherever the context so requires. Notwithstanding the sub-division of the documents into these separate sections and volumes, every part of each shall be deemed to be supplementary to and complementary of every other part and shall be read with and into the CONTRACT so far as it may be practicable to do so.

Where any portion of the General Terms & Conditions of Contract is repugnant to or at variance with any provisions of the Special Conditions of Contract, unless a different intention appears, the provisions of the Special Conditions of Contract shall be deemed to over-ride the provisions of the General Terms & Conditions of Contract and shall to the extent of such repugnancy, or variations, prevail.

Wherever it is mentioned in the specifications that the CONTRACTOR shall perform certain WORK or provide certain facilities, it is understood that the CONTRACTOR shall do so at his cost and the VALUE OF CONTRACT shall be deemed to have included cost of such performance and provisions, so mentioned.

1. EVALUATION OF BID SHALL BE DONE ON FOLLOWING BASIS: -

- (i) Evaluation of the techno-commercial bid will be done first.
- (ii) Only the bids that are meeting the Technical Bid Evaluation Criteria and substantially responsive to the Bid conditions would become eligible for the opening of the priced bids.
- (iii) The tender will be awarded on least cost basis. Techno Commercially qualified bidder with lowest total quoted amount for a particular SOR item shall be ranked as L-1 for that particular SOR item and shall be awarded tender for that particular SOR item.
- (iv) BHAGYANAGAR GAS LTD reserves the right to reject any or all bids without assigning any reason thereof and BGL's decision in this regard shall be final and binding on all the bidders.

2. OTHER CONDITIONS

- a. The entire scope of coverage as specified in the Bidding Document shall be treated as Insurance Contract.
- b. The bidder shall quote the premium rates and total premium against respective areas of coverage for respective sum insured as per format of price Schedule. The total premium will be inclusive of all expenditures to be incurred by the bidders and applicable taxes, duties, GST and surcharge etc. and no expenditure other than those quoted in the SOR will be paid by Bhagyanagar Gas Limited on any account for the defined scope of coverage.
- c. All premium rates & Total premium to be quoted by the bidders will be in Indian Rupees only on firm price basis and shall remain valid during the currency of the policy.

- d. Insurers are free to carry out inspections at site at their cost and risk, if so desired for this purpose. They may examine the site and its surroundings and obtain all information that may be necessary for preparing the bid.
- e. The company reserves the right to increase the sum insured during the policy period by paying the additional insurance premium to the insurer. The additional insurance premium would be strictly as per the insurance premium quoted by the insurer.
- f. The company also reserves the right to decrease the sum insured during the policy period for which the insurer is liable to refund the excess insurance premium collected to the company.

3. ADDITIONAL ATTACHMENTS

Following additional documents are required to be attached necessarily with the un priced bid of tender document on their letter head in addition to forms attached in General conditions of the contract :-

- a. Letter of confirmation by bidder regarding compliance of guidelines, circulars and amendments thereof issued by IRDA from time to time. (as per annexure – A).
- b. Certificate from the head office of the respective insurance companies to deal with Bhagyanagar Gas Limited and also to give the quotation as per Annexure B.
- c. Documentary Evidence in support of meeting Techno Commercial Criteria applicable as per Section: Bid Evaluation Criteria.

THE UNCONDITIONAL COMPLIANCE TO THE ABOVE WOULD BE A PREREQUISITE FOR OPENING OF PRICE BID. SUBJECTIVE/PART COMPLIANCE SHALL BE LIABLE FOR REJECTION OF THE BID.

4. INSURANCE PREMIUM

- (i) The Insurance premium payable is as per the Price Schedule and is inclusive of all taxes & duties. The premium amount shall remain firm during the Insurance period of the policy.
- (ii) **The total premium amount shall be paid by Bhagyanagar Gas Limited in advance.** However, Insurance Company shall provide premium bills in the form of Input Tax Credit Invoice based on the sum insured to avail the Input Tax Credit of GST by Bhagyanagar Gas Limited.
- (iii) **Insurance Policies are to be issued by the insurer directly and that no agent or agency commission will be involved.**
- (iv) **The standard fire and special perils policies are on reinstatement basis and other policies based on cost or reinstated values as may be applicable.**
- (v) **Endorsement of policies shall be considered by the insurer for all the policies, in case of any changes or coverage of additional risks by BGL.**

5. RESPONSIBILITY OF INSURER

The following terms and conditions shall have the meaning hereby assigned to them except where the context otherwise requires:

- i. The bidders are required to quote the premium rates strictly as per IRDA tariff provisions and violation/breach of IRDA tariff provisions will not be accepted. In case of any violation of the IRDA tariff provisions by the insurance company, in the quotation, Bhagyanagar Gas Limited will not be liable for any differential premium in any case. Also there will be no effect on the settlement of the claims.
- ii. The terms & conditions of cover and the wordings of the policies, warranties and clauses should be strictly inline with IRDA provisions & draft policy issued by IRDA from time to time.
- iii. The rates quoted should be with minimum excess as stipulated in the IRDA tariff.(i.e. the first 5% of each and every claim subject to minimum of Rs.10,000/- in respect of each and every loss arising out of Act of god perils and the first Rs.10,000/- in respect of each and every loss arising out of other perils in respect of which the insured is indemnified).

**MEMORANDUM OF UNDERSTANDING SIGNED BETWEEN BHAGYANAGAR GAS
LIMITED AND INSURER**

Bhagyanagar Gas Ltd., Hyderabad (BGL) has appointed M/s _____ (insurer) to issue policies in respect of their unit/establishment situated at _____. In order to establish proper understanding and to provide efficient and satisfactory services by the Insurer, this Memorandum of Understanding (MOU) has been signed between M/s _____ and M/s Bhagyanagar Gas Ltd the parties, hereby agree as follow-

Documentation

1. The underwriters will issue the Premium Receipt and the Cover note for the desired coverage, immediately on receipt of the premium by them.
2. The corresponding policy documents will be issued to Bhagyanagar Gas Ltd. within five working days of the receipt of the premium.
3. Any amendment of the policies shall be confirmed by issuing endorsement within five working days of the receipt of the necessary information/premium from BGL.

Claims

1. A panel of approved Surveyors to be utilized in case of all losses/damages, for which necessary claims are to be lodged, shall be finalized by mutual discussions within 15 days of signing of this MOU.
2. All claims lodged on the underwriters shall be promptly settled as per the following understanding.
 - a) "On Account Payment" (of the order of 90%) in case of loss beyond Rs. 5 lacs shall be released by the underwriters within 7 working days of the receipt of preliminary report of the Surveyors. The preliminary survey report shall be issued by Surveyors within 5 working days of their visit subject to production of minimum required details and information. However, documents required to be obtained from Govt. agencies like Fire, Final Report from Police authorities and Fire Brigade Report etc shall not be binding for release of On Account Payment. The surveyor should attend the site within a period of not more than a week of the reporting of the loss.
 - b) Final payment of the claim shall be made within 15 days of receipt of Final Survey Report and all necessary supporting documents/information from BGL.
 - c) The final survey should be got done by the insurance company within a period of 1 month of the lodgement of the claim.
 - d) The final payment towards the claim will be settled within the above time frame or else the interest rate as per the IRDA guidelines will be charged by BGL.
3. BGL has been authorized for Self Survey in respect of claims with estimated loss upto Rs 20,000 per claim.

SCOPE OF WORK/ SERVICES

Introduction

Bhagyanagar Gas Limited, a joint venture of GAIL (India) Limited, and HPCL, was incorporated in August 2003 as a City Gas Distribution company for distribution and marketing of Compressed Natural Gas (CNG) and distribution of Piped Natural Gas (PNG) to Domestic, Commercial and Industrial Sectors.

The company has been authorized by the Petroleum and Natural Gas Regulatory Board (PNGRB) to undertake CGD projects in the geographical areas of Hyderabad, Vijayawada & Kakinada GAS in Telangana and Andhra Pradesh.

The company has also laid extensive length of steel/MDPE pipes to supply natural gas to various segments of customer's viz. industrial, commercial and domestic. Considering the nature of activities and initial implementation of the CGD Projects, phase wise capitalization is being done in the cities as soon as a PNG Network is charged off in case of Grid and gas supply to industrial customers commenced as the case may be. As far as CNG Stations are concerned, it is capitalized as soon as the station is made ready for operation. Further, new CNG stations are under development/planning stage and will be added from time to time.

CNG Operations:

CNG Daughter Stations: The following facilities have been installed at each Daughter Booster Station:

1 no CNG Booster compressor, 1 no. 2325 Ltrs. Stationary Cascade and 1 no. 15Kg/min car dispenser and associated tubing connections and power supply facilities.

The list of CNG Stations of BGL is enclosed at **Annexure -6**.

There are Mobile Cascades Mounted on LCV. These LCVs shuttle between Mother Station and Daughter Stations. The frequency shall be as per the demand of CNG in the respective station. The LCV shall stand at the daughter station and shall be replaced by another when the pressure drops to the limit when further filling is not possible, normally between 150 to 180 Kg/cm² in daughter station without booster and till 30 Kg/cm with booster compressors. The number of LCV shall enhance based on the number of stations from time to time.

Production of CNG:

- a) Raw Material: The input raw material for production of CNG is natural gas.
- b) Dosing of Odorant: Natural gas is odourless, literally though very mild hydrocarbon smell can be sensed in case of high concentration. As a safety measure, a non-reactive chemical compound called Mercaptan is mixed with the natural gas before it is fed to the compressor. The strong pungent smell of Mercaptan in the CNG can be easily detected even with small quantity of leakage. Therefore, anyone can easily recognize if any leakage occurs. The Dosing of this Mercaptan is carried out through dosing unit/ device which accurately measure the quantity proportionate to the volume of gas flowing in the compressor unit.
- c) Compression: The natural gas at a pressure of 22 Kg/cm² from CGS is fed into the compression unit called CNG Compressor. The gas at 22 Kg/ cm² is being compressed upto

255 Kg/cm², this outlet product of gas at 255 Kg/cm² and meant for use in automotive is called CNG. There are no chemical and physical property changes except the density of the gas. The CNG as produced from the compressor is accurately measured through the Coriolis Mass Flow meter (Micro motion make) fitted at the final discharge of each of the compressor. The total quantity produced is therefore accurately metered at these points itself.

Product Storage and transportation:

- a) Stationary Cascade: Cascades of 3150 Liters water capacity each are installed at the mother station. The gas from the Compressor is directly connected to these cascades through SS Tubes of 3/4" size. Sufficient numbers of isolation valves are provided to isolate each unit during emergency.
- b) Mobile Cascade: Mobile cascade for transporting the product from Mother Station to daughter station are filled at Mobile cascade filling point provided at the mother station. Normally this filling point is provided at an easy egress area. The filling is directly from the compressors and not from the stationary cascades.

Sales Transaction:

- 1) Dispensing: Dispensing to vehicles shall be done in all the stations either Mother station or Daughter stations. The gas either directly from Compressor or from stationary/mobile cascade is connected to the dispensers. The flow meter in the dispensing unit accurately meters the quantity of CNG being dispensed. This is the sales transaction point.
- 2) Piped Natural gas (PNG) - Natural Gas distributed through a pipeline network that has safety valves to maintain the pressure, assuring safe, uninterrupted supply to the domestic sector for cooking and heating / cooling applications. PNG (Piped Natural Gas). Piped Natural gas (PNG) is used for Domestic, Commercial and Industrial Consumption.
