**SPECIAL CONDITIONS OF CONTRACT**

The special conditions of contract shall be read in conjunction with Schedule of rates, scope of work and any other document forming part of contract, wherever Context so requires. In case of any contradictions the Decision of the Engineer-In-Charge will be final and binding on the Contractor. In case of contradiction between Indian or other applicable Standards, Special Conditions of Contract, Specifications, drawings, Schedule of Rates, the following shall prevail in order of precedence:

- i) Letter of acceptance along with statement of Agreed variations.
- ii) Fax / Letter of Intent / Fax of Acceptance
- iii) Schedule of Rates as enclosures to letter of acceptance
- iv) Job / Particular Specifications
- v) Technical / Material Specifications
- vi) Special Conditions of Contract.

It will be contractor's responsibility to bring to the notice of Engineer-in-charge any irreconcilable conflict in the contract documents before starting the work(s) of making the supply with reference which the conflict exists.

1) Time Schedule:

Delivery period will be 4-8 weeks from the date of intimation from the EIC for supply.

Installation, testing and commissioning shall be done within two weeks from date of intimation of BGL.

2) Submission of Drawings:

Supplier shall submit drawings within seven days after receipt of Purchase order/Fax of Acceptance (FOA) whichever is earlier. BGL will review/comment on drawing within ten days of receipt of drawing.

3) Location/Site Information:

Location of site will be informed by BGL Engineer-In-charge OR AS FOLLOWS:

**4) Payment Terms:**

The Payment shall be made in the following manner subject to completion of all contractual requirements: **SUPPLY OF PORTABLE STORAGE CABIN IN HYDERABAD & VIJAYAWADA.**

- 100% payment after supply will be paid within 15 days and acceptance of material at site and the following documents:

or

- 50% advance payment (on receipt of Proforma Invoice) on submission of equivalent amount of BG & remaining 50% after supply within 15 days and acceptance of material at site and the following documents:

Documents to be submitted along with bill:

- I. Invoice in triplicate
- II. GR/ LR
- III. Related datasheets/drawings
- IV. Acceptance of materials at site and Installation certified by OIC.

5) Contract Performance Security:

Bidder will provide Performance Guarantee @ 3 % of annualized order value within 30 days of receipt of Fax of Acceptance (FOA) / Work Order (WO) from the Owner. The contract performance bank guarantee shall be valid 3 months beyond the Guarantee/ Warrantee period.

The Performance Guarantee shall be in form of either Demand Draft or Banker's Cheque or bank transfer through NEFT/RTGS/IMPS into BGL account, or irrevocable Bank Guarantee and shall be in the currency of Contract (issued by any Indian Scheduled bank or a branch of an International Bank situated in India and registered with Reserve Bank of India as Scheduled Foreign Bank).

The Terms also to be read inline with Section Information To Bidders(ITB) (Vol I of II) of Bid Document.

6) Contract Value:

The Quoted prices shall be deemed to be inclusive of all taxes including packing & forwarding, installation, Freight including insurance, duties, GST tax, and other charges as applicable till the completion of the contract and contractor shall not be eligible for any compensation on this account.

The value of work under this contract shall be as per quantities mentioned in the SOR. Actual work may vary to any extent plus or minus to the attached quantities and the contractor must do so as per BGL's requirement.

7) PRICE REDUCTION SCHEDULE (PRS):

If the SELLER fails to deliver any or all of materials within the time period specified in the Order, BGL shall without prejudice to any other remedy(ies) under the order/ contract, reduce a sum calculated on the under mentioned basis. Price Reduction shall be applicable for supplies which are completed beyond the contractual delivery period (of a particular lot) @ ½ % of the delayed delivery value lot wise per week of delay or part thereof subject to maximum up to 5% of the order value of particular lot. The "Delayed delivery value" shall be excluding taxes and duties. Date of receipt of material at site shall be considered as date



of delivery and the same shall be considered for calculation of PRS (lot wise delivery value) as per GPC.

8) PROGRESS OF WORK:

The Contractor shall proceed with the Work under the Contract with due expedition and without delay. EIC may direct in what order and at what time the various stages or parts of the work under the Contract shall be performed. If the Contractor can reasonably comply with this direction, the Contractor shall do so. If the Contractor cannot reasonably comply, the Contractor shall notify the EIC in writing giving reasons.

9) TERMINATION

If in the opinion of Engineer-In-Charge the performance of Party is not found satisfactory, the contract will be terminated by giving 15 (Fifteen) days' notice. Any loss incurred by the Company on this account shall be recovered from the Party. BGL shall also have the right to complete pending jobs under this contract by engaging any other agency at the risk and cost of original Party.

10) Guarantee/ Warranty Period:

The subject item under this order shall be guaranteed against defective materials, workmanship etc. for 12 months from date of installation /commissioning.

11) Transit insurance

Transit insurance for subject items will be in bidder scope.

12) Transportation & Installation

Transportation from vendor's works to BGL sites, after pre-dispatch inspection (PDI) clearance shall be in scope of vendor as per the prevailing rules. Installation at BGL designated sites at various units shall be in scope of vendor.

TECHNICAL SPECIFICATIONS

**1. Scope of Supply:**

The successful Bidder (the “Supplier”) shall complete delivery of Goods along-with its incidental services (if any) as per Specification, Scope of Supply/Job within the period stated in Special Conditions of Contract.

Seller’s scope shall include (a) manufacturing of above mentioned items as per Material Requisition technical specifications; (b) preparation of Quality Assurance / Quality control programme; (c) obtaining Owner’s approval; (d) arranging Inspection and Testing certification; (e) Inspection and obtaining Inspection Release Note; (f) obtaining dispatch clearance; (g) Packing; (h) Transit Insurance, Loading on truck/trailer including and Unloading of Portable Cabins/ Buk House at Bhagyanagar Gas’s store/site.

2. Technical Specifications

Manufacture, Supply, Transportation & Installation of Storage Container /Bunk House/ Portable cabins Hall type with Electrical fittings, Fans & Lighting (Without toilet & furniture).

(15) 4 legs of 8" sizes at all four corners to support structure. (16) All Welding should be carried out using MIG/MMA welding process
