CLARIFICATIONS TO BIDDER'S QUERIES ARE READ AS UNDER:-

- I. Bidders sought clarification on experience of number of projects implemented in CGD sector on RISE With SAP and expressed that implementation of RISE are far and few in CGD.

BGL's Clarification: CGD sector is desirable but not mandatory hence the clause 3.1 of QCBS mentions "CGD sector/Utility vertical / PSU / Government Department / JVs of PSU / reputed private entities". [The "/" is synonymous with "Or"].

- II. Bidders insisted for a clarification whether award of contract will be on L1 or QCBS basis?

BGL's Clarification: It is clarified that the award of contract will be based on QCBS basis where 75% of weightage will be given on technical criteria as mentioned in Table-1 and 25% on price.

- III. Certain bidder requested for a minimum passing percentage (70%) on the technical evaluation to debar non-serious bidders.

BGL's Clarification: Please be assured that the bids will be evaluated meticulously, and individual presentation will also be conducted as mentioned in the tender document which will be enough to debar non-serious bidders.

- IV. "Kindly confirm that the support ext is as per the price given in Sr No 5 of SOR".

BGL's Clarification: Yes support extension is as per Sr No 5 of SOR

- V. On the 70% (offsite) and 30% onsite bidder requested the following clarification:

"We assume that this requirement is only for the implementation phase and not for Post Go Live or for support phase of 6 months after Post Go Live. The bidder can provide all support remotely"

BGL's Clarification: Yes, primarily on-site presence is during the implementation phase and for the first 3-4 weeks immediately after go-live.

VI. There was a request to alter the payment schedule of the implementation.

BGL's Clarification: Alteration to payment schedule will not be possible.

VII. Bidders pointed and sought clarification on 5a under "Application Support" in VOLII of the tender on the penalty on implementation.

BGL's Clarification: The 5a will read as under:

- a. *"The Go-Live of the project is expected to be within 25 weeks (6 months) from the date of project kick-off, any delay may attract penalty of 0.5% per week to a maximum upto 5% of the amount of SI.No.1 of Schedule of rates".*
- b. *Penalty for Post-Go-Live support will be based on either SL.No.4 or SI.No.5 of Schedule of Rates as the case may be.*

VIII. Bidders sought clarification with respect to the location of the on-site visit of their consultants.

BGL's Clarification: The location will be Hyderabad
