SCOPE OF WORK/ SERVICES

Introduction

Bhagyanagar Gas Limited, a joint venture of GAIL (India) Limited, and HPCL, was incorporated in August 2003 as a City Gas Distribution company for distribution and marketing of Compressed Natural Gas (CNG) and distribution of Piped Natural Gas (PNG) to Domestic, Commercial and Industrial Sectors.

The company has been authorized by the Petroleum and Natural Gas Regulatory Board (PNGRB) to undertake CGD projects in the geographical areas of Hyderabad, Vijayawada & Kakinada GAS in Telangana and Andhra Pradesh.

The company has also laid extensive length of steel/MDPE pipes to supply natural gas to various segments of customer's viz. industrial, commercial and domestic. Considering the nature of activities and initial implementation of the CGD Projects, phase wise capitalization is being done in the cities as soon as a PNG Network is charged off in case of Grid and gas supply to industrial customers commenced as the case may be. As far as CNG Stations are concerned, it is capitalized as soon as the station is made ready for operation. Further, new CNG stations are under development/planning stage and will be added from time to time.

CNG Operations:

CNG Daughter Stations: The following facilities have been installed at each Daughter Booster Station:

1 no CNG Booster compressor, 1 no. ranging from 2325 – 4500 Ltrs. Stationary Cascade and 1 no. 15Kg/min car dispenser and associated tubing connections and power supply facilities.


The list of CNG Stations of BGL is enclosed at per RFP annexure

There are Mobile Cascades Mounted on LCV. These LCVs shuttle between Mother Station and Daughter Stations. The frequency shall be as per the demand of CNG in the respective station. The LCV shall stand at the daughter station and shall be replaced by another when the pressure drops to the limit when further filling is not possible, normally between 150 to 180 Kg/cm² in daughter station without booster and till 30 Kg/cm with booster compressors. The number of LCV shall enhance based on the number of stations from time to time.

Production of CNG:

- a) Raw Material: The input raw material for production of CNG is natural gas.
- b) Dosing of Odorant: Natural gas is odourless, literally though very mild hydrocarbon smell can be sensed in case of high concentration. As a safety measure, a non-reactive chemical compound called Mercaptan is mixed with the natural gas before it is fed to the compressor. The strong pungent smell of Mercaptan in the CNG can be easily detected even with small quantity of leakage. Therefore, anyone can easily recognize if any leakage occurs. The Dosing of this Mercaptan is carried out through dosing unit/ device which accurately measure the quantity proportionate to the volume of gas flowing in the compressor unit.
- c) Compression: The natural gas at a pressure of 45-22 Kg/cm² from CGS is fed into the compression unit called CNG Compressor. The gas at 45- 22 Kg/cm² is being compressed up

to 255 Kg/cm², this outlet product of gas at 255 Kg/cm² and meant for use in automotive is called CNG. There are no chemical and physical property changes except the density of the gas. The CNG produced from the compressor is accurately measured through the Coriolis Mass Flow meter (Micro motion make) fitted at the final discharge of each of the compressor. The total quantity produced is therefore accurately metered at these points itself.

Product Storage and transportation:

- a) Stationary Cascade: Cascades of ranging from 3000-4500 Liters water capacity each are installed at the mother station. The gas from the Compressor is directly connected to these cascades through SS Tubes of ¾" size. Sufficient numbers of isolation valves are provided to isolate each unit during emergency.
- b) Mobile Cascade: Mobile cascades of various capacities for transporting the product from Mother Station to daughter station are filled at Mobile cascade filling point provided at the mother station. Normally this filling point is provided at an easy egress area. The filling is directly from the compressors and not from the stationary cascades.

Sales Transaction:

- 1) Dispensing: Dispensing to vehicles shall be done in all the stations either Mother station or Daughter stations. The gas either directly from Compressor or from stationary/mobile cascade is connected to the dispensers. The flow meter in the dispensing unit accurately meters the quantity of CNG being dispensed. This is the sales transaction point.
- 2) Piped Natural gas (PNG) - Natural Gas distributed through a pipeline network that has safety valves to maintain the pressure, assuring safe, uninterrupted supply to the domestic sector for cooking and heating / cooling applications. PNG (Piped Natural Gas). Piped Natural gas (PNG) is used for Domestic, Commercial and Industrial Consumption.
